Public Access – Inheritance Act Claims

The Inheritance Act 1975 protects spouses (including former spouses), cohabitants, children and other dependants when a person dies without leaving sufficient money for the dependent's continued wellbeing. Our barristers can provide you with advice on whether you can make a claim under the Act and can represented you at mediation and in court proceedings to establish the claim. Our barristers can also provide you with written advice and representation when a person dies and you are a beneficiary and / or an executor of the estate, but someone else makes a claim under the Act.

Although this note is specific to claims under the Inheritance Act, our barristers provide advice and representation in a wide range of probate related claims, including claims challenging the validity of wills and administration claims.

Our barristers will guide you expertly through the court process, advising on pre-litigation negotiation and mediation and advising and representing you at the case management hearings and at any final hearing.

Timescales

Timescales for your case may vary depending on factors such as barristers' availability, the value and complexity of the deceased person's estate, your financial needs and those of any beneficiary of the estate.

Claims under the Act must be made within six months of the grant of probate, so <u>as a guide</u> any written advice will be available within two to four weeks <u>where possible</u>.

<u>As a guide</u>, court proceedings for claims under the Inheritance Act tend to take six to eighteen months. This does not include possible appeals.

In most cases we charge fixed fees for our work. This means that we will charge you a set amount of money for each piece of work we undertake. Below we have provided <u>estimates</u> based on the ranges of fixed fees for barristers at Pump Court Chambers.

All fees exclude VAT (where applicable). That means that it is likely that you will have to pay us VAT in addition to the fee at the current rate (presently 20%).

These fees may vary depending on your needs – for example, your fees may be towards the higher end of the range if you need a more experienced barrister and/or you have a more complex case. If you have a particularly complex case, your fees may also be higher than the estimates below. There may also be additional costs for any administrative work involved such as copying or where you agree to engage another person to assist with your case, such as a paralegal. On the first occasion that you instruct us there will be a fixed administration fee of £20 plus Vat.

When quoting fees it will only be to undertake that particular piece of work. There are likely to be many different pieces of work involved in a case such as representation at hearings, advising in conference and in writing and drafting documents. We will always quote separately for each piece of work. <u>Please contact us so we can discuss fees individually with you.</u>

Our barristers range in experience and expertise from QCs to newly qualified barristers. The fee levels set out below will reflect the relative experience of the barrister that you decide to instruct.

Preliminary conference	£1,000 - £5,000
Written advice on your claim	£1,000 - £5,000
Preparation of case, including meetings with you and assistance with drafting of any Court documents	The fixed fee would be calculated at the hourly rate of the appointed Counsel multiplied by the number of hours work required.
	The applicable range of hourly rates is £200 - £500 per hour.
1 Day mediation	The fixed fee would be calculated as above.
First Case Management hearing (first court hearing normally associated with exchanging of information and documents, provision of expert evidence and identifying the issues in the case)	The fixed fee would be calculated as above.
Further Case Management Hearing	The fixed fee would be calculated as above.
Court Hearing to discuss possible financial settlement	The fixed fee would be calculated as above.
