Clinical Negligence

Roy managed a busy medical/clinical negligence practice in Australia primarily advising claimants/plaintiffs in all aspects of their claim including assessing prospects, obtaining appropriate expert advice, drafting claims and pleadings, managing interlocutory matters, advising in preparation for hearing, and representing claimants at mediation or settlement conferences.

He was often instructed in matters involving complex medical care with difficult issues of breach and causation. His past cases have included allegations of incorrect or delayed diagnosis, delayed treatment, negligent performance of surgery, negligent anaesthesia or critical care treatment, negligent post-operative care, negligent obstetric care and birth injury, poor nursing care and falls prevention, delayed patient transport, negligent physiotherapy, and failure to recognise and act on abnormal imaging or pathology results.

In 2021 Roy was asked by the Australian Medical Council to draft the revised chapter '*Negligence, Professional Liability and Adverse Events*' for their publication 'Good Medical Practice: Professionalism, Ethics and Law'.

Healthcare

Across Australia and the UK Roy has experience both prosecuting regulatory matters and advising health practitioners facing disciplinary and regulatory concerns. His cases have included a range of health practitioners including doctors (GP's, specialists, and doctors in training), dentists, pharmacists, nurses, and optometrists.

In New South Wales he regularly prosecuted complex tribunal matters against health practitioners (via the NSW Health Care Complaints Commission). Since moving to the UK he has obtained experience working as a consultant in a leading defendant firm assisting health practitioners facing regulatory investigations, interim order tribunals, and fitness to practice allegations.

Inquests & Inquiries

Since moving to the UK Roy obtained significant experience advising and representing doctors appearing as Interested Persons at Inquests in his role as consultant at a leading health law firm. His cases have involved care issues such as mental health management, suicide risk and prevention, prescribing practices, drugs of addiction, emergency services responses, and transgender care.
